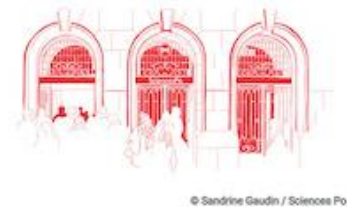

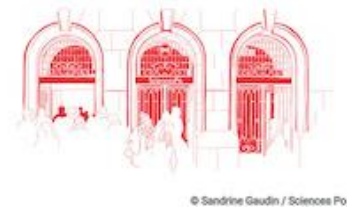

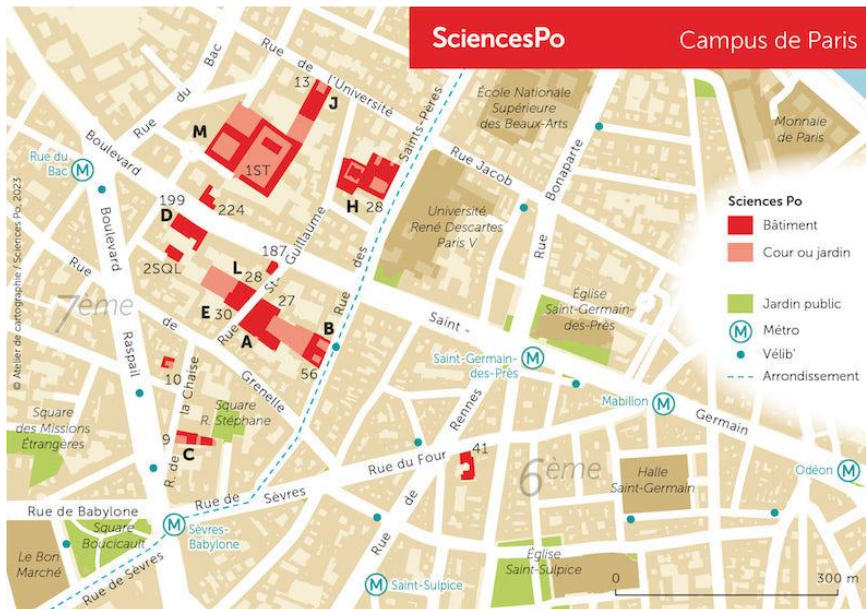

**Four buildings will be of interest to you:**

**Building A:**  
27, rue St Guillaume

**Building B:**  
56, rue des Saints Pères  
(entrance on lower ground level via the garden)

**Building M:**  
1, place Saint Thomas d'Aquin

**Building H:**  
28, rue des Saints Pères  
(Department of Economics – 4th floor)

### **Building A is the main venue:**

- You will **register and collect your badge** for the duration of the congress in the **entrance hall of Building A – the “péniche”**.
- **Opening words, the keynote lectures, the AFSE plenary session and PhD awards**, will all take place in the **Amphitheatre Émile Boutmy**, entrance located on the ground level at the back of the building, just after the *péniche*.
- **Coffee and lunch will be served in the “Petit hall”** that is located on the ground level to the far right of the main entrance.  
*Enjoy your coffee and picnic lunch in the garden, accessible to the left of Boutmy! 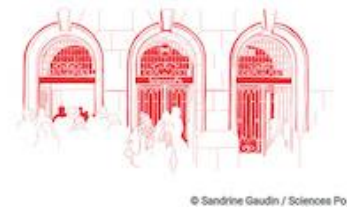

**Building B is an additional venue for parallel sessions in case of affluence.**

- It is **accessible via the garden** that it shares with the main venue, rue Saint Guillaume – the **entrance** to Building B is located on the **lower ground level**, **just off the garden**.

## KEYNOTE SPEAKERS

Christian **GOLLIER** (TSE) – *Inaugural Lecture: June 14th*

*How Do We Express Our Responsibility to Future Generations? Discounting and Carbon Value*



Christian Gollier is Professor of Economics and Director of the *Toulouse School of Economics* (TSE), which he founded with Jean Tirole in 2007.

His research spans the field of economics of uncertainty, environmental economics, finance, insurance, and cost benefit analysis, with a particular interest in long-term sustainable effects. He has published ten books on risk including *The Economics of Risk and Time* (MIT Press), winner of the *Paul A. Samuelson Award* (2001) and *Pricing the Planet's Future* at Princeton University Press in 2012, which he presented at the *6th Arrow Lecture* at Columbia University.

Christian Gollier is one of the authors of the 4th and 5th reports of the *Intergovernmental Panel on Climate Change* (IPCC, 2007 and 2013). In addition, he regularly advises governments on their public investment evaluation policies. He is also president of EAERE, the *European Association of Environmental Economists*.

His recent book *Le Climat après la fin du mois* (PUF 2019) stresses the importance of undertaking action in the face of climate change and has been very successful with the French general public.

Emmanuelle **AURIOL** (TSE, President of AFSE) – *Presidential Address: June 15th*  
*Women in Economics: Europe and the World*

Emmanuelle Auriol is Professor of Economics at the *Toulouse School of Economics* (TSE) and the President of the *Association Française de Science Économique* (AFSE).

She is a bronze medalist of the CNRS (2003), a member of the *Institut Universitaire de France* (junior 2003, senior 2016) and a Fellow of the *European Economic Association* (EEA), of the *CEPR*, of the *European Union Development Network* (EUDN), and of the *CESifo*. She is the editor of several scientific journals, and she regularly collaborates on research and training contracts with the *French Development Agency* and the *World Bank*. She is also a member of the *Conseil d'Analyse Économique* and the *Cercle des Économistes*.



Combining theoretical and empirical approaches, her research focuses on industrial organization and development economics. She studies market failures, whether they are caused by the rent-seeking behaviour of agents with market power, or by cognitive biases such as negative intrinsic motivations, retrograde religious beliefs, discriminatory social norms, especially against women. Her work draws on contributions from both neo-classical economics and behavioural economics.

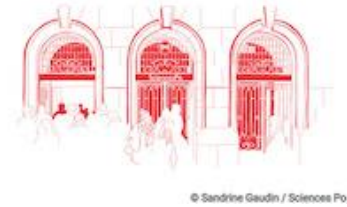

Christian **DUSTMANN** (UCL) – *Jean-Jacques Laffont Lecture : June 16th*  
*The Effects of Immigration on Places and Individuals – Identification and Interpretation*



**Christian Dustmann is Professor of Economics at University College London (UCL) and the founding Director of the Centre for Research and Analysis of Migration (CReAM).**

He is an elected Fellow of the *British Academy* (FBA), the *German National Academy of Sciences*, the *Academy of Europe* (Academia Europæ), the *Econometric Society*, and the *Society of Labor Economists* (SOLE). He also regularly advises government bodies, international organisations, and the media on current policy issues.

Professor Dustmann's work is internationally acclaimed: **he is a leading labour economist working in areas such as migration, the economics of education, the economics of crime, social networks, technology, income mobility, wage dynamics and inequality.**

In 2020 he was awarded the Carl-Friedrich-von-Weizsäcker-Prize by the *German National Academy of Sciences*.

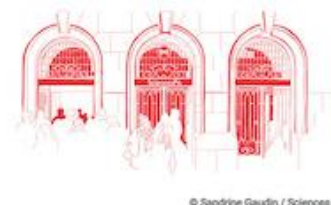

## AFSE AWARDS

### 2023 AFSE PhD Prize Award

The 2023 AFSE PhD prize has been awarded to Mathilde MUÑOZ for her PhD Dissertation entitled *Essays on taxation and international worker mobility in Europe* - research carried out at the *École des hautes études en sciences sociales* (EHESS) and the *Paris School of Economics* (PSE), under the supervision of Thomas Piketty and defended on June, 21st, 2022.



#### MATHILDE MUÑOZ

Mathilde is currently a post-doctoral fellow at the *James M. and Cathleen D. Stone Center on Wealth and Income Inequality* at University of California at Berkeley (UC Berkeley). She will be joining the faculty of UC Berkeley in July 2023 as an Assistant Professor of Economics.

Her PhD Dissertation focuses on the interaction between globalization and redistribution, by studying, with a special focus on Europe, how trade and migration flows respond to international differences in personal taxes and labor market regulations, and by estimating how those flows shape inequalities within and across countries.

### 2023 AFSE PhD Prize - Special mentions

The very high quality of the submitted theses also led the jury to award two special mentions to **Lydia ASSOUD** and **Yohan RENARD**.

Lydia's PhD dissertation entitled *Essays on the Political Economy of Development of the Middle East* was carried out at EHESS under the co-supervision of Thomas Piketty and Ekaterina Zhuravskaya.

Lydia is Assistant Professor of Economics at the *London School of Economics*, Department of International Development. In 2024, she will also become an Academy Scholar at the *Harvard Academy for International and Area Studies*.

Her research interests lie at the intersection of development economics, political economy and economic history, with a particular focus on the Middle East.

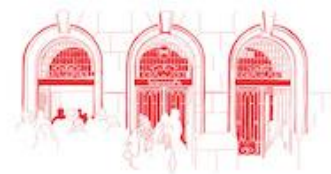
